Keynote Speaker: National Shipbuilding Strategy

Sylvain Cardinal, Director, Large Combat Ship Construction Sector, Public Services and Procurement Canada.

Sylvain is currently the Director General – Large Combat Ship Construction Sector at Public Services and Procurement Canada since July 2019

Prior to that, he was the Senior Director, Canadian Coast Guard Fleet Renewal Directorate where he is responsible for the acquisition of large Coast Guard vessels procured under the National Shipbuilding Strategy. Sylvain has also held various Director positions all at Public Services and Procurement Canada, specifically at the National Fighter Procurement Secretariat and the Defence Procurement Secretariat and as well as with the Special Procurement Initiatives Directorate.

Plenary Session #1: Centralizing and Simplifying Federal Procurement – Reimagining Client Service Delivery

Alexander Jeglic, Procurement Ombudsman, Office of the Procurement Ombudsman.

Mr. Alexander Jeglic has been named Procurement Ombudsman for a five-year term.

Alex is a lawyer by background and most recently served as General Counsel for Private-Public Partnerships Canada Inc., a federal Crown Corporation, where he was involved in the procurement processes for large infrastructure projects. He previously held positions of increased responsibility in the United States and Canada including at the Canadian Commercial Corporation as Senior Legal Counsel and the Australian Trade Commission as Business Development Manager and International Trade Advisor in Washington (DC). Throughout Alex's legal and professional career, he has focused primarily on procurement, contracting and dispute resolution, which will serve him well as Procurement Ombudsman. Alex graduated from Carleton University in Ottawa with a Bachelor of Arts (Law) with a concentration in Business Law in 2000. Concurrent Session #4: Implementing Social Procurement: A Pilot for Women-Owned/Led Catering Businesses in Atlantic Canada
