CONCURRENT SESSION # 3 PRACTICAL INFORMATION ON UNDERSTANDING ACCESSIBILITY CONFORMANCE REPORTS AND ACCESSIBILITY ROADMAPS

Accessibility Conformance Reports (ACR) and roadmaps play an important role in checking for accessibility when we purchase software, hardware and other kinds of Information and Communication Technology (ICT). Suppliers typically provide ACRs as part of the procurement or exploration of the ICT solutions that are available in the marketplace. An ACR should provide the information you need to understand the accessibility of the ICT solution. Successful suppliers in a procurement create roadmaps to outline their plan to address known accessibility defects and how they will continue to remain conformant once they have largely fixed the known issues.

The presentation will offer an overview of the recently established National Supply Chain Office within Transport Canada, highlighting its important roles in strengthening Canada's supply chains and bolstering economic competitiveness. Polina Hristeva will also provide updates on the Office's initiatives which aim at enhancing efficiency and resiliency throughout Canada's supply chains, including mitigating impacts from disruptions.

Polina Hristeva, Director, National Supply Chain Office, Transport Canada

Polina Hristeva is leading a team focused on advancing cross-government and industry supply chain data/digitalization initiatives, performance, and resilience response, as well as coordination on Canada-U.S. supply chain issues.

Polina joined Transport Canada 15 years ago and occupied positions with increasing responsibilities. She was leading the development and implementation of key horizontal files related to surface transportation (highways, international bridges, trucking), Canada-U.S. collaboration, multimodal transportation system performance, economic impact analysis of transportation system disruptions, as well as national and regional supply chain visibility initiatives and fluidity projects.

CONCURRENT SESSION # 16 DIVESTMENT OF CONTROLLED GOODS AND/OR SPECIALIZED ASSETS

The session will review and discuss complex divestment considerations and provide guidance for client departments in their divestment planning process. We will review guidance on how to identify Controlled Goods and specialized assets. The session will review constraints on general divestment planning and conditions relating to specialized assets such as: the Defence Production Act Section 35 / Controlled Goods; Foreign Government Third Party Re-Transfer restrictions (International Traffic in Arms Regulations), Export and Re-Export Controls (U.S CCL), Intellectual Property, Right of First Refusal Clauses, Hazardous Materials (HAZMAT), Dangerous Goods, Complex Removal Plans, Third Party managed assets, etc. Understanding the various controls and security provisions in place can assist departments and materiel managers in forecasting their divestment needs and timelines.

Christopher Murphy, Manager, GCMil (GCSurplus) and Specialized Sales, Public Services and Procurement Canada

Christopher Murphy has been with the PSPC/GCMil program for 10 years and the Manger for the past 4 years.

CONCURRENT SESSION # 21 CHIEF PROCUREMENT OFFICER IN CANADA

In July 2021, the Office of the Procurement Ombud (OPO) published its first report on Chief Procurement Officers (CPO), which focused on examining various jurisdictions which already have a CPO. In this presentation, OPO will present on their follow-up study

which examines the potential benefits of a Chief Procurement Officer within the Canadian federal context.

While the federal government currently does not have a CPO, this presentation will explore the gaps in the present procurement policy structure and present the CPO as a means of addressing the shortcomings in the policy structure.

The presentation will discuss different models of the CPO that have been researched and present their findings. This session is meant to challenge attendees to think about what changes could be made to the current federal procurement system and how the presence of a CPO could improve federal procurement.

Alexander Jeglic, Procurement Ombud, The Office of the Procurement Ombud Mr. Alexander Jeglic has been re-appointed as Procurement Ombud for another five-year term.

Alex is a lawyer by background and previously served as General Counsel for Private-Public Partnerships Canada Inc., a federal Crown Corporation, where he was involved in the procurement processes for large infrastructure projects. He also held positions of increased responsibility in the United States and Canada including at the Canadian Commercial Corporation as Senior Legal Counsel and the Australian Trade Commission as Business Development Manager and International Trade Advisor in Washington (DC). Throughout Alex s legal and professional career, he has focused primarily on procurement, contracting and dispute resolution which has served him well as Procurement Ombud.

Alex graduated from Carleton University in Ottawa with a Bachelor of Arts (Law), with a concentration in Business Law, in 2000. In 2001, he completed the Cornell Law School Paris Summer Institute program in international and comparative law and in 2003 completed a Juris Doctor (JD) degree from Loyola University Chicago School of Law in Chicago, Illinois with a certificate in International Law. Alex has also taught procurement law at Carleton University for several years.

David previously worked at the Office of the Procurement Ombud (OPO) as the Director of Communications and Corporate Management, prior to joining the Department of Fisheries and Oceans as Senior Director of National Portfolio Strategy. He rejoined OPO as Deputy Procurement Ombud in April 2017.

The positions held during his career include Director of Standards at the NATO School in Oberammergau Germany, Deputy Director of Air Force Training at 2 Canadian Air Division, and Project Director of the Air Force Integrated Information and Learning Environment (AFIILE).

Two powerful Lean principles are: making the work visible and using simple routines to improve the work as we do it.

- Most of our processes are invisible, so it can feel like we are working in the dark, and, despite working so hard, spinning our wheels. It is difficult to manage or improve what we cannot see – so making the work more visible can help free up time, increase collaboration, balance workloads, and get more done without working harder.
- Building simple improvement routines into our work can help us solve problems and adjust as we go forward, resulting in reduced frustration and more agile processes.

In this talk, Craig will share his views on:

• The "tax" we pay on invisible work.

- Examples of practical ways to make your own work, and your processes, more visible so that everyone gets more done with less effort, the first time through.
- The hidden cost of doing the work without also improving it.
- Practical ways to build simple improvement routines into the work to solve recurring problems once and for all, while building gratitude/recognition, morale, happier clients, and freeing up your time.

Craig Szelestowski, Founder, Lean Agility Inc., Director, Lean Programs, Telfer Business School Centre for Executive Leadership, University of Ottawa

Craig is a Lean/Agile transformation specialist with more than two decades of experience implementing dramatic turnarounds in the public sector. He founded Lean Agility Inc. in 2010 to apply Lean and Agile exclusively to government organizations. With his coaching, his procurement clients have sped up their processes by 70%, improved client satisfaction and created outstanding levels of employee engagement.

Craig has served multiple times as a part-time professor at the Telfer School of Business at the University of Ottawa. He is the Director of Lean programs at the Telfer Centre for Executive Leadership and has taught Lean to Telfer's MBA students.

Some of these assets can become surplus regularly with divestment occurring multiple times a year. GCSurplus offers departmental partners the ability to use period contracts to divest of some of these assets.

The presentation will describe the role of ECCC's newly created Outreach and Procurement Community Development team. It will highlight the advantages of having such a client training and community development focused team, in relation to the new Directive on the Management of procurement (such as workforce capacity, collaboration between contracting authorities and business owners, identifying and addressing the department's needs with respect to the necessary competencies, capacity and professional development in procurement management), the Procurement Management Framework (including service delivery, continuous learning and innovation, workforce capacity) and an opportunity to increase knowledge on the Government of Canada's procurement priorities (socio-economic considerations, indigenous procurement, etc). It will demonstrate the qualitative and quantitative results achieved since the creation of the group to show how such a function can help departments in their continued efforts to improve client relations and procurement knowledge and competence.

While tires remains a reluctant purchase, the impact to our environment in terns of waste and GHG is large, often hidden by the idea that we recycle tires. And while recycling is good, it is not the best use in retaining the value of the material.

This presentation is to demonstrate the 3 levels of circularity in tire value retention, showing the highest level of green procurement consideration compared to the current solutions and famed within the Industry challenges of supply and demand.

Objective: The audience will leave with a strong example of circularity and GHG reduction, giving light to the importance of this reluctant purchase, in addition to understanding how tires fits into Green Procurement as a strategy along with other polymer groups like plastics.

He also developed a national spares management strategy and guideline that identifies key considerations for the optimum management of nationally managed spares and materiel across the organization including the assessment and optimization of warehouse / storage space.

William Santary, Shared Services Canada

William has worked in both the private and public sector in the Information technology field for approximately 25 years. In his 20 years working in the Canadian government, he has work on a variety of IT systems. Developing IT applications that track radioisotopes for researchers at Agriculture Canada, to creating a system to automate the never-ending changes to IT accounts and subsystems required at Global Affairs Canada during their "Posting" season which involves hundreds of employees changing positions and location all within the same month. Currently William is exploring the world of Internet of Things and helping SSC find ways to help other government departments take advantage of the possibilities the use of smart devices and sensors.

CONCURRENT SESSION # 57 THE CYBER SECURITY CERTIFICATION PROGRAM FOR INDUSTRY

The Government of Canada announced at Canadian Association of Defence and Security Industries (CANSEC 2023) that it will introduce mandatory cyber security requirements in select defence contracts through the forthcoming Canadian Program for Cyber Security Certification (CP-CSC), designed to mirror the U.S. DoD's Cybersecurity Maturity Model Certification program. This program will increase the cyber resilience of the supply chain to better protect sensitive but not classified information. While this program will initially apply to defence contracts, it may eventually expand to other Government Departments. This presentation will provide an overview of the program, its key objectives, the planned implementation, and the intended application in DND. This will be a joint presentation by PSPC's CP-CSC Secretariat and DND.

Marc Lanouette, Strategic Advisor for Supply Chain Resiliency and Systems Security Engineering in the Materiel Group, Department of National Defence

Marc Lanouette is the Senior Engineer and section head responsible for Cyber Materiel Assurance and Supply Chain Resilience policy and processes in the Materiel Group at the Department of National Defence. He retired from the Royal Canadian Navy as a Commander after 21 and a half years of service in February of 2019 to take his current role. His final military posting was as the Lead Systems Security Engineer for the Royal Canadian Navy in the Director General Maritime Equipment Program Management division and the lead for the Materiel Group Cyber Materiel Assurance Program. He served in HMCS Regina, HMCS Iroquois, HMCS Montréal and HMCS St-John's as a Combat Systems Engineer.

- the normal procedural rules of the trade agreements; and
- exceptions, set-asides, and other trade agreement flexibilities.
