PSPC's Senior Officer Emergency Procurements team will provide an overview of procurement support for responses to emergencies, including topics such as government policies and frameworks, emergency contracting authority, and National Security Exception.

Andrea Andrachuk, Director General Specialized and Emergency Acquisitions Sector, Public Services and Procurement Canada

Andrea also served for 14 years in the Canadian Armed Forces as an Aerospace Engineering Officer.

CONCURRENT SESSION #3

UPDATE ON THE TRANSFORMATION OF PROFESSIONAL SERVICES PROCUREMENT AT PUBLIC SERVICES AND PROCUREMENT CANADA

The presentation will provide an overview of the current context of professional services procurement and the transformation initiatives that are underway.

Claudine Paquin, Senior Manager, Professional Services Transformative Solutions Sector, Public Services and Procurement Canada

Claudine Paquin has been working with Public Services and Procurement Canada (PSPC) since January 2008, where she has held several roles within the Procurement Branch. With extensive experience in procurement process planning and development, as well as contract management, she joined the Procurement Transformation and Partnerships Directorate in February 2025.

From 2017 to 2025, she worked in the Professional Services Procurement Directorate, with a nearly two-year secondment to the Pandemic Response Sector. During this time, she led the team responsible for procuring equipment related to PCR testing, rapid tests, and border testing — playing a critical role in Canada's national response to the health crisis.

Earlier in her career, from June 2011 to October 2015, Claudine was part of the team overseeing the procurement processes and contract awards for the RP-1 and RP-2 real

property services management contracts. She also contributed to building procurement capacity by providing training to the procurement community from 2015 to 2017.

Dedicated, thorough, and with a strong understanding of strategic procurement issues, Claudine Paquin is recognized for her ability to bridge operational needs with the Government of Canada's broader transformation objectives.

Judith Rorai, Director, Procurement Transformation and Partnerships Directorate, Public Services and Procurement Canada

Judith Rorai is Director of Professional Services Transformation and Partnerships at Public Services and Procurement Canada, where she helps lead government-wide efforts to modernize professional services procurement through digital innovation, vendor performance systems, and outcomes-based contracting. With over 20 years of experience in business management and strategic leadership - both in Canada and internationally - Judith has held senior roles in real property, investment management, and executive advisory. Prior to joining the public service, Judith led national sales and marketing strategies for global luxury brands, including Christian Dior and Osborne & Little.

A graduate of the London School of Economics and McGill University, Judith also holds executive certifications in leadership, innovation, change management, and brings a collaborative, client-focused approach to driving transformation and delivering public value.

CONCURRENT SESSION #4

CYBER SECURITY PROCUREMENT VEHICLE (CSPV) 3.0 - THE EVOLUTION OF AGILE PROCUREMENT IN THE CYBER SECURITY SPACE

Since its official launch in 2019, the Cyber Security Procurement Vehicle (CSPV) has utilized many different types of agile procurement processes to meet the needs of numerous GoC partners. From the early growing pains of CSPV 1.0, to the continued challenges faced under CSPV 2.0, the team will walk you through how lessons learned have helped guide the evolution of the vehicle to where it is today as CSPV 3.0. We will use real examples to show how agile procurement isn't always faster but is still a necessary pursuit for complex IT procurements and can improve the procurement experience from all perspectives.

Gary Cooper, A/Senior Director, Cyber Security, Networks & Satellites, Shared Services Canada

Gary Cooper has been working in the field procurement within the Government of Canada since May 2006. He's had the privilege to work on many interesting, challenging, and complex procurements, as well as work with many great people over his 19-year career that has taken him from DND, to PSPC, and now to SSC where he's worked since 2014. More recently, Gary and his team created and launched SSC's first agile procurement, the Cyber Security Procurement Vehicle (CSPV) in May 2019, which now is 5 years old and has pre-qualified over 160 vendors in SSCs Secure Supplier Eco-system. Committed

to lifelong learning, Gary is continuing continually trying to gain efficiencies within the procurement process, to offer SSC and its partners the best experience possible.

Vanessa Woodend, Senior Procurement Officer, Enterprise IT Procurement, Shared Services Canada

Vanessa Woodend is a seasoned Senior Procurement Officer with over five years of public sector experience, complemented by a background in private sector government procurement. She specializes in managing complex cybersecurity procurements, ensuring the effective and timely acquisition of critical security solutions. As the lead for the Cyber Security Procurement Vehicle (CSPV), she oversees procurement strategies that support national cybersecurity priorities, balancing compliance, efficiency, and innovation. With a strong understanding of government policies and industry best practices, Vanessa plays a key role in safeguarding public sector digital infrastructure through strategic procurement and vendor management.

His successful award of the agile procurement for the purchase of Canada's replacement Secure Remote Access (SRA) solution in 2022 gave him a robust foundation in both the complex and agile procurement space. Rob leverages his complex procurement experience on a daily basis while leading his team through the ever-evolving cyber security procurement landscape.

CONCURRENT SESSION # 5

THE MARRIAGE OF MATERIEL MANAGEMENT AND FINANCIAL ACCOUNTABILITY

The importance of the marriage of materiel and finance cannot be overstated. They are intertwined, interlinked and often confusing. Bronwynn Guymer is the Senior Policy Analyst for Materiel Management in DND and the CAF. She has extensive Materiel Management experience from operational front-line units up to corporate oversight and coordination. She has completed the Certified Supply Chain Transformation Architect Training, is certified in Supply Chain Operations Reference Model and has led multiple change initiatives within DND.

Mike Rainville, National Manager, Uniform & Equipment Program Operations, Royal Canadian Mounted Police

Mike started his career in the Federal Public Service in 2008 as a warehouse technician in the RCMP's Uniform & Equipment Program. He then moved to a client services representative role and also worked within the Program's Design & Technical Authority Section. In 2011, Mike began to take a particular interest in the procurement and material management aspects of the UEP and worked closely with the Forecasting, Accounting & Administration Section manager prior to her retirement. After successfully winning the competition for the position, Mike continued in this critical role which included material forecasting for all RCMP uniform supplied by UEP, managing the Program's budget, initiating requisitions for competitive solicitations and engaging in low dollar value purchases for both operations & maintenance and uniform. Mike took over as National Program Manager in June of 2024. Additionally, Mike has worked intimately across multiple modules with the RCMP's instance of SAP and is engaged with the RCMP's transition to S4HANA.

Passionate about public sector procurement and driven by the Customer Service Experience, Martin Chénier is an award-winning business and people manager who spent the last two decades helping Industry and the Federal Government buy and sell professional services.

Known as "PACman" within the procurement community, Martin is the President and Founder of The Procurement Alliance of Canada; a subscription-based service providing practical resources, webinars, advisory services, and self-directed learning material to public sector procurement professionals, their clients, and suppliers.

Earlier in his career, Martin served two mandates as National Chair of Government Relations for the \$15B Industry Association of Staffing Services; he was a Forty Under 40 recipient in 2008; winner of the Consumer's Choice Award for Best Staffing Agency in Ottawa Gatineau; and Branch Manager of the Year for Outstanding Achievement and Service Excellence. He supports Public Sector organizations with practical knowledge transfer, coaching, and training services related to professional services procurement, and is an active Industry representative on Government committees and working groups.

Kevin Arsenault, Senior Director, Operations, CORCAN, Correctional Services Canada

Kevin started his career with the Public Service at CORCAN (Correctional Service Canada) in 2007 in Moncton, NB as a Financial Officer. He occupied several financial positions with CORCAN in the Atlantic Region before moving to Ottawa in 2016. Kevin later took on the role of Director, Manufacturing for two and a half years, before accepting a deployment to the Director, Security Operations position (which he occupied for two years). Since September 2021, he has occupied the position of Senior Director, Operations with CORCAN.

Paul Harvey, Director Construction, CORCAN, Correctional Services Canada

Paul began his career with the Correctional Service of Canada (CSC) in 2000. He has worked in several frontline operational roles as Corrections officer, Parole Officer, Intelligence Officer, Project Officer in Security, Regional Administrator Intelligence, and Assistant Warden Operations at various institutions in the Quebec region. In 2017, Paul began working with CORCAN as regional manager of Operations. In 2019, he became Director of Textiles and Services CORCAN, and since January 2025 he is Director of Construction CORCAN. Paul enjoys the challenge presented by the designation of CORCAN as a Special Operating Agency (SOA) operating within a correctional environment.

Connor Emeny, World-Record Holding Athlete & Author of "All In"

Connor Emeny is a world record-holding endurance athlete, adventurer, and author who lives by the mantra Dare to Dream. He is the youngest person on Earth to complete an Ironman on all seven continents, a feat that took four years, relentless determination, and an unshakable belief in what's possible.

His journey was far from easy. Racing across diverse terrains – from the scorching heat of Africa to the icy extremes of Antarctica – Connor faced grueling physical and mental challenges. Chasing Antarctica, the final and most difficult leg of his mission, pushed him beyond his limits. To even reach the starting line, he and his team had to endure a 23-day sailboat expedition across the notorious Drake Passage, navigating some of the roughest and most unpredictable waters on the planet.

But Connor's story isn't just about endurance sports – it's about breaking barriers, defying expectations, and proving that anyone can achieve the extraordinary when they commit fully to a goal. He believes that resilience isn't just about surviving obstacles but about embracing them as opportunities for growth.

His journey is proof that when you go ALL IN, you unlock potential far beyond what you thought was possible.

CONCURRENT SESSION # 9

STRATEGIC, COMPREHENSIVE, AND INTEGRATED ASSET MANAGEMENT: THE INVESTMENT MANAGEMENT CONTINUUM, FROM A LIFE-CYCLE PERSPECTIVE

Procurement folks, have you ever wondered what happens with an asset after it's been procured? Materiel management and supply folks, have you been wondering what's the decision-making process for business owners and project managers?

- Have you asked yourself why TBS has combined multiple policies contracting, materiel management, real property, project management, and investment planning under the "Policy on the Planning and Management of Investments"...?
- Last election, have you heard about balancing government's operating budget while maintaining investments?

This session provides a moment to pause, to step out of our usual "silo'd" perspectives, and step back to look at a broader picture: how the policy suite makes sense, and consists in a continuum from an integrated life-cycle perspective.

It will present a focused and strategic overview of integrated asset management, emphasizing the investment management continuum from a life-cycle

perspective. Attendees will gain valuable insights into effective and integrated asset management practices throughout the entire life-cycle of assets, and its benefits for the organization.

Over the last few years, departments have gone through a few rounds of reviews to find efficiencies: integrated life-cycle management may be what most departments will need to have a better line of sight and horizon on their future financial position, including mitigation of risks and potential liabilities.

Throughout this session, some elements will be addressed from various perspectives: strategic, tactical, and operational.

Brian Leonard, DG Financial Operations and Procurement, SDO for Procurement, SDO for Materiel Management, and Chief Procurement Officer (CPO), Transport Canada

Brian Leonard is the Director General of Financial Operations at Transport Canada, where he is also the Chief Procurement Officer and the Senior Designated Official for Procurement, Material Management, and Real Property. Brian joined the department in August 2024, and among other deliverables, is the DG Lead for the Integrated Asset Management Project which will ensure integrated life-cycle management of Transport Canada's assets.

Prior to joining Transport Canada, Brian spent over 15 years at Employment and Social Development Canada, most recently as the Deputy Chief Financial Officer responsible for corporate financial planning and resource management.

Brian is a Chartered Professional Accounting with a business degree from Carleton University.

Ève Corbin, A/Director, Special Project: Asset Management Secretariat, Financial Operations and Procurement (FOP), Finance and Management Services (FMS) Group, Transport Canada

Ève Corbin is an enthusiastic, genuine and accomplished leader in federal public service, with a strong background in procurement and materiel management. Last October, Ève was mandated to initiate, develop and spearhead a new enterprise-wide initiative for the management of investments, Transport Canada's (TC) *Strategic Asset Management and Streamlining Project* (SAMSP). TC's senior officials are committed to this initiative, part of the department's horizontal review, as it aligns on long-term departmental and government priorities, and aims to visibility on the department's future operating budget.

Ève started working in administrative services (for various departments), before developing her professional expertise through major, complex procurements at National Defence (2008-2019), and joining Transport (2019), where she built – and lead – departmental procurement governance, oversight, policy, and reporting.

Throughout her career, Ève had the chance to work with inspiring and generous leaders. By growing into a transformative leader, driven to make her work purposeful, and by leading meaningful changes, Ève offers a similar development opportunity to her colleagues. Committed to give forward, Ève volunteers in various fashions. Over the years, she coached and mentored for various programs. At CIPMM, she served as a Board member (2019-2021), Chaired the *Learning Events Committee* (2019-2021), and Co-Chaired the *Virtual Summit* (2020). Since 2023, she Co-Chairs PSPC's <u>Client Advisory Board</u> (CAB), the interdepartmental forum on procurement.

Ève is also compelled to "make right" unfair situations: she champions a culture of respect, fairness, and dignity, integrating diversity, equity, and inclusion. She's an active member of Transport diversity networks, such as the *Women+ Network*, and the *Steering Committee* of the *Network for Persons with Disabilities*. As a high potential intersectional person, Ève was TC's nominee for the *Mosaic Leadership Development Program*, *Cohort 2*.

CONCURRENT SESSION # 10 TAKE CHARGE OF YOUR CAREER - UPDATES ON TBS PROFESSIONALIZATION, OUTREACH AND ENGAGEMENT INITIATIVES

Ever wonder what the future of professionalization, outreach and engagement looks like for the GoC Procurement and Materiel Management communities? HOW NET-ZERO PROCUREMENT HELPS WIN THE GHG REDUCTION TRIFECTA

- 2. Explain the 4-part definition of Net-Zero Procurement (NZP).
- 3. List the three elements of the climate change GHG reduction trifecta.

- 2. Reduce all companies' GHG emissions to net-zero by 2050 or sooner
- 3. Fix the climate crisis by 2050 or sooner"

Dr. Bob Willard, Founder and Chief Sustainability Champion, Sustainability Advantage

Bob is a leading expert on sustainability justifications, sustainability reporting frameworks, and sustainable procurement. Over the last 23 years, he has given over 1,800 presentations, has authored six books and published two white papers. He provides six <u>Master Slide Decks</u> and over a dozen free, open-source tools and resources for sustainability champions and procurement professionals.

For the last few years, Bob has focused on <u>Sustainable Procurement</u> and <u>Net-Zero</u> <u>Procurement</u> as market forces to mobilize businesses in the race to net-zero GHGs. He currently serves on the <u>Circular Innovation Council</u> board and the <u>Sustainable Purchasing</u> <u>Leadership Council (SPLC)</u> board – he co-developed the <u>SPLC Navigator</u> with SPLC staff. Bob is on the core faculty of the Canadian Business for Social Responsibility (CBSR) <u>Sustainable Procurement Fellowship</u> program, is an Ambassador for the <u>Sustainable</u> <u>Procurement Pledge</u>, and is an Advisor to the <u>Mission from MaRs – Net-Zero</u> <u>Procurement Mission</u>. He teaches a 4-webinar <u>ISSP course on Sustainable Procurement</u> which provides guidance on how to use his free, open-source <u>Sustainable Procurement</u> <u>Toolkit</u> and <u>Net-Zero Procurement Toolkit</u>.

Bob serves on the <u>B Corp Standards Advisory Council</u> and the <u>Whitby Sustainability</u> <u>Advisory Committee.</u> He was one of five inaugural inductees into the <u>International Society</u> <u>of Sustainability Professionals (ISSP) Hall of Fame</u> in 2011, has received three <u>Clean50</u> awards including a <u>Lifetime Achievement award</u> in 2023, and has earned six "<u>Best for the</u> <u>World - Overall</u>" and five "<u>Best for the World – Community</u>" awards since becoming a Certified B Corp in 2012. Sustainability Advantage was the first company to reach the highest Diamond tier of Canada's <u>Net-Zero Challenge</u> in 2023.

CONCURRENT SESSION # 36

FUTURE-PROOFING PROCUREMENT & MATERIEL MANAGEMENT

In an increasingly volatile, uncertain, complex and ambiguous (VUCA) environment, Procurement and Materiel Management may struggle to keep up, getting overloaded with unexpected priorities and events while trying to do more with the same level of resources.

In this interactive talk, Craig will share examples relevant to Procurement and Materiel Management showing how public sector organizations have future-proofed themselves against the challenges of this increasingly VUCA world by:

- Making work visible to make it easier to manage, and to prevent overload.
- Building lightweight check-in routines to adjust to quick changes.
- Running quick experiments to learn and adjust on the fly.
- Freeing up and reserving capacity for "unexpected" new priorities.
- Create a psychologically safe environment to enable the above four objectives.

A handful of exercises make these concepts more vivid, allowing participants to try out some experiments on their own on their return to work.

Craig Szelestowski, Founder, Lean Agility Inc., Director, Lean Programs, Telfer Business School Centre for Executive Leadership, University of Ottawa

Craig is a thought leader in Continuous Improvement, Lean, and Agile in the North American public sector. He serves as the Director of Lean Programs at the Telfer Center for Executive Leadership, the executive education arm of the business school at the University of Ottawa. He founded Lean Agility Inc. in 2010 to apply continuous improvement approaches to knowledge work / service organizations in the public sector. With his coaching, his clients have sped up procurement by 70% or more, creating satisfied clients and engaged, relieved, Procurement staff. He contributes to Canadian Government Executive magazine and other publications. He is a frequent speaker at a list of conferences and events too long to state here. He founded the annual Lean Government Summit in 2011.

CONCURRENT SESSION # 37

AGILE PROCUREMENT APPLIED TO CLOUD ... NAVIGATING THE LITIGIOUS LANDSCAPE

SSC is applying its Agile procurement process 3.0 (APP3.0) to cloud procurement. In February 2024, SSC launched its initial challenged based solicitation for the provision of Infrastructure as a service (IaaS) and platform as a service (PaaS) with the intent to award 2 to 3 task authorization contracts for a period up to 25 years. Prior to the closing of the prequalification, one of the vendors submits 3 successive complaints to CITT.

During this presentation SSC will present the procurement approach, and share lessons learned of CITT determination.

RETHINKING GOVERNMENT CONTRACTING: BEST VALUE AND NEGOTIATED RFPS

This session will highlight the results from two studies recently completed by the Office of the Procurement Ombud on 'Best Value in Federal Procurement and Negotiated RFPs. In the first study, we examined how the concept of Best Value (BV) has evolved in competitive procurement, explored tensions created by the expanded criteria, and highlighted best practices and recommendations that may offer the procurement community and policy makers some guidance. In the second study, we examined whether the federal government should adopt the negotiated RFP process as a more flexible option to traditional tendering formats.

Alexander Jeglic, Ombud, The Office of the Procurement Ombud

Mr. Alexander Jeglic has been re-appointed as Procurement Ombud for another five-year term.

Alex is a lawyer by background and previously served as General Counsel for Private-Public Partnerships Canada Inc., a federal Crown Corporation, where he was involved in the procurement processes for large infrastructure projects. He also held positions of increased responsibility in the United States and Canada including at the Canadian Commercial Corporation as Senior Legal Counsel and the Australian Trade Commission as Business Development Manager and International Trade Advisor in Washington (DC). Throughout Alex's legal and professional career, he has focused primarily on procurement, contracting and dispute resolution which has served him well as Procurement Ombud.

Alex graduated from Carleton University in Ottawa with a Bachelor of Arts (Law), with a concentration in Business Law, in 2000. In 2001, he completed the Cornell Law School Paris Summer Institute program in international and comparative law and in 2003 completed a Juris Doctor (JD) degree from Loyola University Chicago School of Law in Chicago, Illinois with a certificate in International Law.

Alex has also taught procurement law at Carleton University for several years.

DID YOU SAY ENGAGEMENT!? AN AGILE APPROACH TO VENDOR ENGAGEMENT True Industry engagement is key to an efficient procurement process.

Evolution of technology and the Directive on Management of Procurement allow different - and pleasant - ways to engage with vendors. For example, how many times did you think that more interactions and less written exchanges would have been much more efficient? The principles of an Invitation to Refine (ITR) offer an opportunity to improve Canada's transparency, build trust with vendors, and increase our capacity to harvest the best that Industry has to offer. These simple principles and tools can be used with most types of competitive solicitations and procurements processes.

ETHICAL PROCUREMENT: COMBATTING HUMAN TRAFFICKING, FORCED LABOUR AND CHILD LABOUR IN GOVERNMENT SUPPLY CHAINS

This session will discuss what Public Services and Procurement Canada (PSPC), as the central purchasing agent of the Government of Canada, is doing to promote ethical procurement, foster positive human and labour rights outcomes, and safeguard federal procurement supply chains. PSPC's foundational and current activities in ethical procurement will be discussed as part of an ongoing and evolving public dialogue to enhance public procurement. The session will include case studies and discussions on current and upcoming ethical procurement requirements and resources.

Laura Unitt, Manager, Strategic Policy Sector, Public Services and Procurement Canada

Since she began working for the Government of Canada in 2005, Laura has worked for Employment and Social Development Canada, Environment and Climate Change Canada, and most recently with Public Services and Procurement Canada.

Laura has been the manager of the Ethical Procurement Team since January 2022, and has been leading the team's work to deliver on the department's commitments under the National Strategy to Combat Human Trafficking. Under Laura's leadership, the team is developing: policy instruments to set out departmental human and labour rights expectations; tools and guidance documents for suppliers to foster compliance; ethical procurement best practices; and examining long-term approaches to identifying and mitigating the risks of forced labour, child labour, and human trafficking in federal procurement supply chains.

Patricia Carpentier, Policy Analyst, Strategic Policy Sector, Public Services and Procurement Canada

Patricia joined the Government of Canada in 2007 as an intern procurement officer at Public Services and Procurement Canada. She has spent most of her career in procurement at PSPC and has also worked for the Royal Canadian Mounted Police and the Canadian Space Agency.

BEST PRACTICES FOR INCLUDING INDIGENOUS BENEFITS IN YOUR CONTRACTS

The presentation will explore Indigenous procurement in Canada, beginning with an overview of the current landscape. It will examine key policies such as the Procurement Strategy for Indigenous Businesses (PSIB) and the Nunavut Directive, then delve into the current state of the Indigenous procurement toolkit. This includes Public Services and Procurement Canada's (PSPC) new clauses that support Limiting to Indigenous Offers (LIO) and Indigenous Participation Plans (IPPs). The presentation will highlight best practices for using these tools to meet Canada's obligations under Comprehensive Land Claims Agreements (CLCAs) and to advance local reconciliation. A new template designed to support procurement officers in applying IPPs will also be introduced. No prior experience with Indigenous procurement is required, though some familiarity with federal procurement processes will be beneficial, as portions of the presentation will address topics in greater technical detail.

Jacob Tummon, Manager, Indigenous Procurement Policy Directorate, Public Services and Procurement Canada

Jacob Tummon is a Manager at Public Services and Procurement Canada, where he specializes in Indigenous procurement policy. His previous experience includes supporting the implementation of Article 24 of the Nunavut Agreement on federal procurement in Nunavut while at Indigenous Services Canada, as well as providing policy advice at the Treasury Board of Canada Secretariat. He has also contributed to negotiations on government procurement chapters in Canada's trade agreements.

Sebastian Printup, Policy Advisor, Procurement Branch, Public Services and Procurement Canada

Sebastian Printup joined PSPC's Indigenous Policy team in 2018, where he led PSPC's implementation of the Nunavut Directive. Half-Cree and half-Algonquin, Sebastian grew up in both traditions, attending grade school in Kitigan Zibi while returning to Eeyou Istchee to live the traditional Cree lifestyle on his grandfather's trapline as a beneficiary of the James Bay and Northern Quebec Agreement (JBNQA). Sebastian has a strong understanding of Aboriginal Law, having earned a BA in Law from Carleton University before graduating law school with JD from the University of Ottawa. He has also bicycled across Canada twice, giving him a unique perspective on Canada.

Tyler Zdan, Procurement Team Leader, Procurement Branch, Public Services and Procurement Canada

Tyler joined IPPD at the beginning of 2023, after having worked in PSPC's Western Region in various procurement roles since 2016, bringing with him his experience in front-

line procurement. Tyler has also worked at Agriculture and Agri-Food Canada, the Canadian Food Inspection Agency, and at the department that is now known as Indigenous Services Canada. Tyler co-led the development of the suite of Indigenous Procurement clauses that were recently released in the CMI tool and the Standard Contract Clause Inventory.

Sustainability Advantage was the first company to reach the highest Diamond tier of Canada's <u>Net-Zero Challenge</u> in 2023.
