#### Plenary Panel #1: Opening FPT Plenary Panel: Indigenous Procurement Panel

# Concurrent Session #3: The Office of the Procurement Ombudsman (OPO) digs deeper on "Low Dollar Value (LDV) Contracting" and "Dispute Resolution in Vendor Performance Management

Alexander Jeglic, Procurement Ombudsman, Office of the Procurement Ombudsman

In April 3, 2018, Mr. Alexander Jeglic became Canada's Procurement Ombudsman for a five-year term.

Alex is a lawyer by background and most recently served as General Counsel for Private-Public Partnerships Canada Inc., a federal Crown Corporation, where he was involved in the procurement processes for large infrastructure projects. #### Plenary Session #4: National Ship Building Strategy

**Randy Roberts,** Director General, Large Ship Construction Sector, Marine Sector, Public Services and Procurement Canada

Mr. Roberts has thirty-five years of procurement and contracting experience in both the Public and Private Sectors, half of which have been in the Marine field. He assumed his current position in 2017 wherein he is responsible for the management of the contracts for Large Non-Combat ships being built for the Canadian Coast Guard and Royal Canadian Navy under Canada's National Shipbuilding Strategy.

In 2005, he returned to shipbuilding transferring to the Joint Support Ship project, as part of the team that was to procure

the new replenishment ships for the Navy. In 2006, he transferred to the Department of National Defence as the Senior Procurement Advisor to the Director General of Aerospace Equipment Program Management and served as the first Director of Aerospace Procurement until 2007. Upon completion of French language training in 2008, he transferred to the Directorate of Materiel Comptrollership as the Manager of the In-Year Capital Equipment Programme. In 2010, he returned to the position of Director of Aerospace Procurement. In 2012, he transferred to the Procurement Services division as the Director of Electronic Systems Procurement where he was responsible for the provision of procurement and finance support to Information Management/Information Technology, Space and Cyber projects.

Mr. Roberts is also a retired Naval Reserve Officer. He held a number of logistics, training, executive and command positions, both full and part-time, during his 38 years of service.
