



Sales and re-marketing of Canadian Surplus Controlled Goods and Specialized Assets




# **GCMil Program**



- ✓ GCMil was a joint initiative between the Department of National Defence (DND) and Public Works Government Services Canada initially established to remarket surplus military assets to foreign governments.
- Service provision has been expanded to included the other government departments that possess controlled goods or specialized assets.
- ✓ Our mandate is to remarket and sell surplus assets to foreign governments and select private industries, in an effort to obtain the best possible value for the Crown.



### **BALANCING POLICY**







#### **Controlled Goods**

- Controlled Goods are primarily goods, including components and technical data that have military or national security significance, which are controlled domestically by the Government of Canada and defined in the Defence Production Act (section 35).
- ✓ Defense articles originating from the United States are controlled by the United States Munitions List—part 121 of the United States International Traffic in Arms Regulations
- This applies to goods, regardless of where they are manufactured, that are manufactured from technical data originating from the United States and are controlled by the International Traffic in Arms Regulations
- We ensure Canadian companies are registered under the Controlled Goods Program or foreign nation equivalent




#### Controlled Goods and GCMil






#### **GCMil Website**

- ✓ GCMil primarily uses a restricted website that allows authorized foreign affairs communities and militaries to access information related to surplus Canadian controlled goods, sensitive and specialized assets.
- ✓ This site provides the military, client government departments, foreign affairs and defence industry communities, in Canada and abroad, with pertinent information concerning the sale of surplus Canadian military assets as well as surplus controlled and specialized assets from other Government of Canada departments and agencies.
- ✓ The GCMil website allows potential buyers to be connected with the GCMil team to coordinate and negotiate the sale of these goods.
