

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST CONTRACT SIMPLIFICATION INITIATIVE

The Contract Simplification Initiative (CSI) was created to respond to supplier concerns that:

- > The contracting process is overly complex; and
- Our contract terms and conditions are not in line with industry practices.

The AI Method of Supply pilots CSI by:

- Using updated, modernized, and simplified solicitation and contract documents;
- Using plain language; and
- Reflecting modern practices

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST AGILE PROCUREMENT AND INNOVATION

 Early client and supplier engagement integrated into the procurement process
 Shortlist of eligible bidders established for each requirement

 Instead of prescriptive specifications, requirements will focus on suppliers seeking solutions, promoting innovation.
 Delivery of solutions in an iterative manner

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST HOW WERE SUPPLIERS PREQUALIFIED?

Three key criteria were used:

- **1. Al Ethics:** how suppliers address ethical considerations when delivering Al
- 2. Al Implementation: successful delivery of Al services, solutions, and products
- 3. Al Talent: qualified to deliver AI expertise, experience, other skill sets
- ➢ 74 suppliers prequalified.

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST IS AI SOURCE LIST THE RIGHT TOOL FOR YOU?

The AI Source List is right for you if:

- The requirement includes an element of AI
- ✓ Has a total value of \$9M or less
- Required AI technologies are commercially available

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST OTHER CONSIDERATIONS

- Client departments must forward their AI requirements to the PSPC AI procurement group for direction on how to process their requirements.
- Adherence to applicable policies (procurement and technical) is required (e.g. Contracting Policy, Management of IT, etc.)



ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST START THE PROCESS

- A. Identify the problem you wish AI to solve
- B. Determine which band your requirement belongs in:
 - 1. Band 1: Up to \$500K before taxes
 - 2. Band 2: Up to \$4M before taxes
 - 3. Band 3: Up to \$9M before taxes
- C. Start developing the procurement strategy

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST PREPARE THE PROCUREMENT DOCUMENTS

Prepare:

- ✓ Statement of Work (SOW)
- Solicitation and resulting contract clauses
- Notice of Proposed Procurement (NPP), etc.

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST ISSUE THE PROCUREMENT DOCUMENTS

 Post the NPP and solicitation (including SOW, etc.) on BuyandSell.gc.ca.

 Email all suppliers prequalified for the applicable band for your requirement, to advise them that an Al opportunity has been posted.

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST HOLD A SUPPLIER ENGAGEMENT SESSION

- The purpose of this session is to help prequalified suppliers decide whether they have a solution to meet your needs.
- This is the opportunity for:
 The Client to discuss the requirements
 Suppliers to ask questions
- Aim to host session between 5-10 calendar days after the solicitation posting date.

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST SUPPLIERS SELF-IDENTIFY

Within five calendar days after the engagement session, suppliers must express their interest in bidding.

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST REDUCE BIDDING POOL

- A maximum of 10 suppliers can be invited to bid.
- You can choose up to three from the list of suppliers who have selfidentified.
- The remaining self-identified suppliers will be randomly selected by PSPC.

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST INVITE SUPPLIERS TO COMPETE

Invite the selected suppliers to compete:

- Notify selected suppliers by email
- Update NPP on BuyandSell to release the list of suppliers selected to bid.





ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST RECEIVE AND EVALUATE BIDS

- Proposals will be evaluated by Canada and may include in-person or virtual bidder presentations
- Winning bidder(s) will be selected in accordance with solicitation documents
- Canada may encourage two or more bidders to work together

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST AWARD CONTRACT(S)

Once the evaluation is completed and necessary contract approvals are obtained, the contract(s) can be awarded.

The contractor(s) can now begin the work!

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST AI PROCUREMENT PILOT

- 1. PSPC is working with CSPS on the first procurement to use the Al Source List. The solicitation was issued on BuyandSell on Feb 28, 2019.
- 2. CSPS, on behalf of various federal regulatory organizations, has a requirement for an interactive hosted cloud-based regulatory evaluation platform.
- 3. Al Requirement: An interactive user-friendly interface to search, analyze, visualize and generate reports on over 2,600 regulations.
- 4. Agile Process:
 - Up to 3 contractors to develop prototypes.
 - > Then, one contractor selected to deliver a production-ready AI solution.

ARTIFICIAL INTELLIGENCE (AI) SOURCE LIST NEXT STEPS

- PSPC is finalizing tools/websites to support broader use of the AI source list by clients.
- 2. The AI Source List will be refreshed regularly to add new suppliers and make improvements.
